The Director, Indira Gandhi Rashtriya Manav Sangrahalaya (IGRMS), Bhopal, invites Online Bids in the prescribed form under the two Bid System i.e. Technical and Financial Bid for execution of work - Supply, installation, Testing and commissioning of Streetlighting in IGRMS campus (from Gate no.1 to Office complex) of Indira Gandhi Rashtriya Manav Sangrahalaya (IGRMS), Bhopal.
2. The System of tender shall be adopted, comprising of the financial bid. Tender documents may be downloaded from CPPP site <http://eprocure.gov.in/eprocure/app> as per the schedule as given in critical data sheet. Financial Bid should, inter alia, indicate price and other commercial / financial terms against the items mentioned in the Tender Document.
3. Bid Submission:  
Applications / intending or interested Bidders are invited to submit their online proposal after carefully reading the Request for Proposal (RFP) by providing (a) Financial Bid clearly mentioning (i) Financial Proposal respectively. Such proposals are to be submitted online within the stipulated date and time as mentioned in the Bid document as given in critical date sheet.  
Bids shall be submitted online only at CPPP website: <https://eprocure.gov.in/eprocure/app>.  
Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.
4. Earnest Money Deposit (EMD)/ Bid Security Declaration:  
(a) The Earnest Money Deposit (EMD) of Rs. 28405/- (Rupees Twenty Four Thousand Four Hundred Five only) refundable (without interest) should be deposited / submitted by all the interested bidders except Micro and small Enterprises (MSEs) as defined in MSE Procurement Policy issued by Department of Micro, Small and Medium Enterprises (MSME) or are registered with Central Purchase Organization or National Small Industries Corporation (NSIC) or Startups as recognized by Department of Industrial Policy & Promotion (DIPP).  
(b) Further, in lieu of Bid Security, bidders are required to submit a “Bid security declaration” accepting that if they withdraw or modify their bids during the bid validity period they will be suspended for the time specified.
